8. 20MPH SPEED LIMITS IN TARVIN - CONSULTATION

Once adopted the Estate will be eligible for speed limit consideration.

In each case a broker £50.00 Administrative Charge needs to be added to the above.

All three offer a reduced premium (5% less) if Council will enter a three-year agreement. If Council chooses Inspire via Axa, the lowest quote, and agrees to a three year agreement the premium payable, including the admin charge would be £1,703.01.
